**Call to Order:** Meeting was called to order by Traci Peterson at 7:02 p.m.

## **Activities Director Report:**

- Spring Coaches meeting was held this afternoon
  - Sports and activities will only be held if students are physically returning to buildings
  - Many ideas are being discussed and implemented to keep teams and clubs connected
- Ted is holding a meeting on Thursday for all coaches and advisors
  - Will explain the Grant process

# **Co-President's Report:**

- First ever virtual Zoom video conference call meeting!
- Treasurer Board positions filled
  - Julie Dorn Club Treasurer
  - o Cheryl Krampitz Store Treasurer
  - Will be voted in at funding meeting
- Dana Callahan will be the Vice President for the 2020-2021 Booster Club Board while she resumes her role of co-chair of fundraising
- Store Manager and Senior party chair positions still open
  - Penny will volunteer for the senior party but unable to take the lead position as she is new to the community
  - Job descriptions were sent out to Team Leads last Friday
    - No responses
  - o Brenda will keep checking store surveys for interest
    - Follow up with one response to senior party chair
  - Suggested to reach back out to Kelly Rausch and Leslie Richmond for a shared role
  - Cym will connect with Katie Martin to share the Communications position

- Stacy and Traci met with Ted and Gwynn regarding the funding grants
  - 60% of the grants have been used so far
    - \$43,701 has been used which leaves \$24,907 unused
  - If their club/sport was affected by the school closure and are unable to use their funds for the items granted by the Booster Club by the May 1<sup>st</sup> deadline Gwynn will send an email with the following options
    - First option: Submit a change request to Stacy Cranbrook by email that will be voted on by the board
      - Need to be dated by Monday, April 20<sup>th</sup>
      - Purchases need to be completed by the May 1<sup>st</sup> deadline
    - Second option: Re-submit those funds towards next year's grants
      - They will be given first priority
      - Remain under \$1,500
      - Not considered a roll-over, it is a new submission towards next year's funds
      - Require a board vote in June
      - Limited to one request per club/team
  - Ted will put the grant request in to a Google Doc to be submitted electronically
    - Ted has a meeting with coaches/advisors on Thursday so will discuss/explain
    - Send Google Doc out on Friday
  - Money granted is spent through the Activities Office
    - All money is managed and approved

# **Secretary's Report:**

- Traci motioned the approval of the March meeting minutes. Laura seconded the motion. Board voted and motion carries. Minutes were approved
- Email will be sent out regarding the location of the May meeting

# **Treasurer's Report:**

- Financial reports and profit and loss budget were distributed
- School closure has impacted our store sales
- Solid sales during spring conferences
  - Down about 20% from last year
- Variance is sales income on reports is most likely due to sales tax
  - Christine's report does not include sales tax while Mary's does
  - Sales tax is paid quarterly
    - Mary will pay July's bill in June
    - Will have the number by next week

#### **Communication's Report:**

- Website has been updated with the 2019-2020 Membership Donors list
- Traci and Cym met last week to brainstorm ideas for social media accounts during this time of uncertainty
  - Don't want to be absent but need to refocus from funding to other ideas
  - Held a fun contest for people to post a picture of them wearing their Tonka gear while at home to win a store gift card
  - Suggestion to fill the disconnection gap between the elementary schools, middle schools and high school since all the schools feed into the high school
  - Discussed how now may not be the time for so many things since the store is closed and no new membership drive
  - Spring sports are engaging via Zoom and other platforms
    - Ted will provide Cym with information on what is planned and share a Google Doc of ideas

# **Committee Reports:**

## Membership/Website:

- No new members
  - Not actively recruiting at this time
- Worked with Cym to update the membership list that was posted on the website

#### **Booster Store:**

- Actively looking for a Store Manager replacement
- The May/June clearance sale is pending based on if students will be back in the building
- Minnetonka Baseball Association picture day has been cancelled
- The Pre-Sale for Booster Club members has been cancelled
- If/when students are back in school the focus will be on advertising for the 25% sale
- No word yet on the June 10<sup>th</sup> all staff breakfast
- If spring sports/clubs seasons start and go later in to the summer, possibly the store hours could too
- Slat walls are pulling a bit more but not an immediate concern at this point
- Will open for plant sale pick up if able

#### **Volunteer Coordinator:**

- Brenda has received 70 survey's so far
- 7 out of the 21 days will need new Team Leads
  - Team lead doesn't have to be there for both shifts but be available for phone calls/texts if needed
  - Board members may forward the survey to incoming Freshman families that they know may be interested in volunteering
  - Brenda sent the survey to the people on the waitlist

#### **Fundraising:**

- Unfortunately, all the great fundraising ideas and opportunities have been cancelled for the remainder of the year
  - Now is not an appropriate time for ask for money
  - Will pursue the ideas next year

#### **Senior Party:**

- Bibs have been ordered for next year and will combine the 64 left from this year
- Plant sale ended on Monday
  - Angie has been discussing pick up options on May 9<sup>th</sup>
    - May need to do a drive through pick up in the MHS parking lot
    - Will not have merchandise or yard signs for purchase at that time
    - \$7.000 (incld. tax and retail price) sold
- Sold 200 yard signs quickly, ordered 50 more that also sold quickly and have an order of 50 more coming next week
  - Great to have signs available to show support to the class of 2020
  - 3 requests for scholarships for signs that Angie approved
- We are in a unique situation that is frequently changing
  - o If graduation occurs on June 9<sup>th</sup>, we will keep our venue if congregating in large groups is a possibility
  - If graduation is on the alternate dates in July or August, Angie has been talking to Mr.
     Erickson regarding alternatives
    - Possibly do a senior party in conjunction with senior day
- Angie is meeting with senior party committee to discuss options on Wednesday
- Looking for ways to support the seniors
  - Yard signs
  - o Instagram page "Tonka 2020" for people to submit a photo and plans for their future
    - May turn submissions in to a video to play on senior day
- Clear Channel Advertising donated a spot on the 101/7 billboard to put an encouraging message to seniors to show support and unity
- A Minnetonka parent designed a tumbler with" Tonka Quarantine 2020" on it
  - Will offer as a fundraiser but no plans to push it
